

GUIDELINES FOR ABSTRACT SUBMISSION

Eligible Participants Include

- High School and College students
- Medical students Residents and Fellows.
- Research Associates, Research Scientists, and Healthcare Management students
- Naturopathy, Ayurveda, Yoga professionals.
- Public health experts and allied health practitioners

Eligible Abstracts

- Original studies conducted during your school, college, residency, or fellowship years with major contributions from the presenting author.
- Works previously submitted may be resubmitted if significantly improved in the past 12 months.
- The word count for the abstract body (excluding title, authors information institutions, tables, images, and spaces) should not exceed 450 words

Case Reports: Interesting and unique case reports will be considered

Review & Selection:

Abstracts will be peer-reviewed by a faculty panel based on scientific merit, clarity, originality, relevance, and clinical impact.

Rules & Regulations

- One author must be registered for the conference to present.
- Multiple submissions are allowed but requires separate registration.
- Accepted abstracts must be presented in person: virtual presentation requests will be considered case-by-case.
- Decisions of the scientific committee are final and binding.
- Presenters are responsible for their own travel and accommodation arrangements.

\$200 travel grants will be awarded to 12 selected students.

Submission:

E-mail your one-page abstract or summary in a word file as an attachment to GIMC, Scientific Committee. Fill the Submission form available on website.

Abstracts may be submitted at any time until March 31, 2026.
Notification of acceptance within 10 days of submission.

Abstract Submission & Presentation Fees

A non-refundable abstract submission fee of \$25 is required at the time of submission. Authors whose abstracts are accepted may present their abstract in conference by paying a fee of \$250.
